Salt Shed: Highway Supt. – Jeff Mann has been checking into installing a salt shed. He reported there are two companies that supply them Calhoun & Clearspan. Jeff is looking at 40'x60' or 50'x50' building size and would be placed on the north side of the town barn parking lot. Jeff will get some pricing for the February meeting. Supervisor Prendergast will look into possible grant money.

Town of Torrey Water District:

Water samples have been acquired and Benton was reimbursed for Jayson Hoovers mileage and hourly rate.

Water District # 1 Ext:

Supervisor Prendergast was contacted by Jeremy Delyser (Clark-Patterson-Lee) regarding this district. Jeremy stated the timeline predicted is: Advertise for bids in February, open the bids prior to the March

town board meeting, construction in April. His conversation with the railroad has determined an upfront payment of \$42,000, they no longer accept annual lease payments. Jeff Smith from Municipal Solutions will be contacting Benton regarding the bonding of the new water district.

Water District # 5: (Earls Hill Road) Jeremy stated he would have the Map/Plan/Report ready for another public hearing by the end of January.
