Town of Torrey:

The proposed Torrey WD # 1 which will received water from the Town of Benton ends at Davey Road, residents south of Davey Road to Dresden are not included in any of the proposed water districts. The Villages of Dresden & Penn Yan will not supply any more water to future districts. Any proposed district from Davey Road south would need approval from the Town of Geneva to purchase water.

Public Hearing:

A Public Hearing was held March 20th, 2018 @ 9:00 A.M. in the Benton Town Hall regarding the truss business on Havens Corners Road. They have requested a "PILOT" agreement along with tax exempt. Councilman, Quackenbush attended the hearing and was the lone attendee and reported, "They stated any comments would be taken into consideration and a decision made at a later date".
