Supervisor Prendergast opened the meeting at 7:00 P.M. with the Pledge of Allegiance.

Water District # 1 Extension: Jeremy Delyser of Clark – Patterson-Lee engineering firm was here to explain the delay in accepting bids for construction. Also attorney, Jeff Graff presented written instructions on the final requirements. Stating that no bids can be accepted that exceed the Capital Budget. The town will need additional money from USDA along with a new map, plan and report. Attorney Graff stated required steps needed to proceed with the district. 1) He will need to know if the new project cost exceeds the threshold established by the NYS Comptroller. 2) Town Board sets a public hearing, notice of public hearing, hold the public hearing, at the close of the public hearing the town board must adopt a resolution determining that it is in the pubic interest to authorize the increase of the maximum amount., Town board passes the resolution and must adopt an order approve the increase in the maximum amount and subject to permissive referendum. 3) After the time passes for the permissive referendum, or, if the petition is file, after the vote on the proposition submitted at referendum is held and the vote is affirmative only then can the order be filed. During Permissive referendum the Controller can not make its order until that period passes or if the petition is filed, unless the vote on the proposition submitted at referendum was affirmative. Mr. Delyser stated that he will contact USDA for additional money to complete the project. Bids can only be held for 60 days. The Town Board tabled the bid acceptance until the new figures come out.

**Approval of Minutes:** Motion was made by Richard Harper seconded by Brian Murphy to approve the minutes from the May 9<sup>th</sup>, 2018 meeting as presented. Motion was carried.

#### Water District # 5

Water District # 5 (Earls Hill Road). Supervisor Prendergast and Clerk Wolfe met with Jim Colizzi to discuss the progress on this district. Mr. Colizzi is still talking to residents and acquiring signatures on the petition.

#### Old Business:

Generator: Richard Harper received a proposal from Finger Lakes Power Systems in the amount of \$21,650.00. Mr. Harper stated that he has requested a proposal from Dailey Electric and will also ask Sloth Electric. It was suggested to contact Brian Winslow, Emergency Management for information on possible grants. Mr. Harper stated there is a grant application that is due by June 20<sup>th</sup> he could use the

quote from Finger Lakes Power Systems to apply for it. We will also add for the generator in the 2019 Town Budget. (Town of Benton Complex is set up with Brian Winslow, Emergency Management)

A letter will be sent to Sheriff, Ron Spike thanking him for the providing the "SWEAPS" program. Also a thank you to Deputy Sheriff, Brian Tomion.

Supervisor Prendergast was asking of there was any place to donate the toys/furniture that was thrown away at the clean up day. Eleanor Parker stated that the Once Again Shop doesn't have the capability. A lot of the stuff just needed to be cleaned up and could be re-used.

### New Business:

Resolution regarding "Protecting New York's Lakes from Harmful Algae Blooms". After board discussion is was decided to pass the resolution. (Below).

Hometown Energy presented a fix price contract for propane, 1000 Gallons for 2018-2019 Price per gallon \$1.449. Motion was made by Glenn Quackenbush, seconded by Alan Tomion to accept the contract. Motion was carried.
