Approval of Minutes:

Motion was made by Richard Harper seconded by Glenn Quackenbush to approve the minutes from the April 8<sup>th</sup>, 2026 meeting as presented. Motion was carried.

**Old Business:**

Race Property – Waiting to hear from Brian Race on the purchase.

Local Law # 1 Solar Moratorium – Filed April 17<sup>th</sup>, 2026 with the state (Is law as of that date).

**New Business:**

Bostrom Property: At this time there has been no decision on the use of this property, the town board requested that Mr. Bostrom contact his attorney in turn, his attorney to contact Benton’s attorney. This is to possibly allow a building structure (Stairs) on Benton property to allow access to his property. Mr. Bostrom’s deed states (ROW only to repair the water line).

Mr. Bostrom stated that the resident to north won’t allow them on the ROW.

AG & Markets: Municipal Shelter Inspection and Dog Control Inspection reports completed on 4/21/26 and rated “Satisfactory”.

Tax Collector: Final payment has been given to the Yates County Treasurer.

Historian: Schoolhouse Tour June 21, 1-4 P.M. Stephanie Olsen will be there to receive people from the four. Stephanie also asked about placing a port-a-potty at that location. Tom Fulkrod said he would check pricing.

**Highway/Water:**

Jayson presented the 2026 Expenditure of Highway Money (Needs board signatures). Motion was made by Richard Harper, seconded by Bruce Kerrick to approve the 2026 Expenditure of Highway money. Motion was carried.

Jayson reported that they are working on a main break a this time on Pre-Emption Road.

Jayson also wanted it known that discussion with Brian Race, (we don't need property all the way down to 14A, the smaller area north of the salt shed is what I have requested.)

**Water District # 7:**

Attorney Graff has contacted the State Comptroller's office on any updates for approval. At this time he hasn't heard back. This application was filed with the state December 1<sup>st</sup>, 2025.

**Zoning:**

Tom Fulkrod reported that he broke 100 permits for this year. 80 COO & COC plus Fire & Safety Permits.

There was a fire in Bellona this evening – Reddy Road.

We received a call about another solar project, but was after the moratorium took effect.

We still need the final draft on the Stuart Solar projects.
